

# Creator Management Agreement

BeanBox Agency Inc. • Ontario, Canada • Month-to-Month Non-Exclusive Agreement

## 1. Purpose

Creator hires Agency to help manage, promote, publish, and grow Creator's adult content business. This Agreement is intended to be clear, professional, and easy to understand.

## 2. Services

Agency may provide services including content scheduling and posting; social media promotion and strategy; fan engagement and DM/chat management; pricing, bundles, PPV, and sales strategy; content organization, editing, captions, and promotional materials; account support, reporting, payout tracking, and basic administration; and lawful distribution of Creator content across websites, adult platforms, social platforms, clip stores, promotional pages, and other channels selected by Agency.

## 3. Non-Exclusive Relationship

This Agreement is non-exclusive. Creator may work with others, promote independently, or maintain other accounts, provided that Creator does not interfere with accounts or content actively being managed by Agency.

## 4. Term

This Agreement begins on [Start Date] and continues month-to-month unless terminated under this Agreement.

## 5. Commission and Payouts

Agency will retain 33% of Net Revenue and Creator will receive 67% of Net Revenue. "Net Revenue" means amounts actually received after platform fees, refunds, chargebacks, payment processor deductions, and similar mandatory third-party deductions. Agency will pay business expenses unless otherwise agreed in writing. Creator payouts will be made on the 1st and 15th of each month for cleared funds available for payout.

## 6. Account Access and Management

Creator authorizes Agency to access, manage, post to, promote, and operate Creator's approved accounts and content channels as needed. Creator also authorizes Agency to communicate with fans, subscribers, customers, and potential customers on Creator's behalf, including through direct messages, comments, inboxes, and customer support channels.

## 7. Content Ownership

Creator retains ownership of Creator's content, name, likeness, persona, and brand. Creator grants Agency a non-exclusive, worldwide license during the term to use, publish, edit, crop, caption, promote, distribute, repost, advertise, and monetize Creator's content solely to perform Agency's services. This license does not transfer ownership. After termination, Agency may continue using already-published promotional materials for up to 30 days to wind down active campaigns and links, unless faster removal is required.

## **8. Consent, Age, and Legal Compliance**

Creator confirms that Creator is at least 18 years old and legally permitted to create adult content. Creator agrees to provide valid government ID and any required age or identity verification records before Agency posts or monetizes explicit content. Creator also confirms that all content provided to Agency is lawful, consensual, and features only adults age 18 or older. If another person appears in content, Creator must ensure that person is 18 or older and has signed an appropriate written consent and release.

## **9. Creator Control**

Creator is never required to perform or create any specific act, scene, custom request, or type of content. Agency may suggest content ideas, niches, pricing, captions, and promotional angles, but Creator has the final say over what Creator personally creates.

## **10. Platform Rules**

Both Parties agree to follow the rules of any platforms used, including adult platforms, social media platforms, payment processors, hosting providers, and promotional services. Agency may remove, edit, blur, crop, caption, or decline content if needed for compliance or risk reduction.

## **11. Privacy and Confidentiality**

Agency will treat Creator's legal name, ID, private contact information, account information, banking and payment information, and unpublished content as confidential. Creator agrees to keep Agency's internal strategies, pricing systems, documents, workflows, scripts, passwords, business contacts, and private communications confidential. This section continues after termination.

## **12. No Guaranteed Results**

Agency will make reasonable professional efforts to grow Creator's business, but no specific income, follower growth, subscriber count, or platform result is guaranteed.

## **13. Taxes**

Creator is responsible for Creator's own taxes, filings, and personal financial obligations. Agency may provide payout summaries or basic records, but Agency is not Creator's accountant, lawyer, or tax advisor.

## **14. Independent Contractor**

Creator is an independent contractor and not an employee, partner, or joint venturer of Agency.

## **15. Termination**

Either Party may terminate this Agreement with 30 days' written notice. Agency may terminate immediately if Creator provides illegal content, false identity information, content involving minors, non-consensual content, stolen content, platform fraud, threats, harassment, or other serious misconduct. On termination, the Parties will reasonably cooperate to close out payouts, account access, active campaigns, and file handoff.

## **16. Governing Law**

This Agreement is governed by the laws of Ontario, Canada, and any dispute will be handled in Ontario unless the Parties agree otherwise in writing.

## **17. Entire Agreement**

This Agreement is the entire agreement between the Parties. Any amendment must be in writing and approved by both Parties.
